

RETAIL CONSIGNEES FOR FSIS RECALL 030-2014

FSIS has reason to believe that the following retail location(s) received ground beef products that have been recalled by Wolverine Packing Company. This list may not include all retail locations that have received the recalled product or may include retail locations that did not actually receive the recalled product. Therefore, it is important that you use the product-specific identification information, available at http://www.fsis.usda.gov/wps/portal/fsis/topics/recalls-and-public-health-alerts/recall-case-archive/archive/2014/recall-030-2014 in addition to this list of retail stores, to check meat or poultry products in your possession to see if they have been recalled.

After a recall release is issued, FSIS personnel begin gathering primary distribution information from the recalling firm. This process is lengthy and involves contacting each establishment at each level of distribution. As FSIS identifies retail establishments (e.g., supermarkets), the agency will update the distribution list. Please continue to check back over the coming days for updates.
